Approval by Saginaw County Road Commission for the requested route on this application constitutes a permit in compliance with Sec. 722, P.A. 300 of 1949, as amended, under the following Conditions and Restrictions:

1. Permit must be carried in the vehicle.
2. Speed limit not to exceed 35 m.p.h.
3. Normal Legal Loadings only.
4. Time of Day _____
5. The Saginaw County Road Commission has the right to suspend this agreement if weather or road conditions warrant such action.
6. Any of the following actions shall immediately void the permit and subject the applicant to appropriate legal action:
 - (a) Misrepresentation of information set forth in an application for permit;
 - (b) Noncompliance with the conditions, restrictions, or provisions on which a permit is issued;
 - (c) A change or erasure on a permit.
7. The permittee shall be responsible for damages to the road, to persons, and to property caused by or arising from operations covered by this permit. The permittee shall indemnify and save harmless the Saginaw County Road Commission, the department and all of their employees from any and all suits, claims, and damages of every kind arising out of, under, or by reason of this permit, or from operations covered by this permit.
